**CERTIFICATE OF EMERGENCY  
PROFESSIONAL TECHNICAL SERVICES AND VIABLE ALTERNATIVE FINANCING  
PURSUANT TO P.L. 30-01**

I, Anthony C. Blaz, certify and declare, under penalty of perjury, the following to be true:

1. I am the Administrator of the Guam Economic Development Authority ("GEDA");
2. GEDA's mandates state that GEDA shall act as a central financial manager and consultant for the Government of Guam, its agencies and instrumentalities for financial guidance and assistance;
3. GEDA is working with the Office of the Governor to secure viable financing alternatives to meet a Consent Decree order dated October 22, 2008 by the U.S. District Court Chief Judge Frances M. Tydingco-Gatewood;
4. That U.S. District Court Judge Gatewood had issued an Order dated February 13, 2009 requiring that the Government of Guam begin making weekly payments of \$1.0 million to fund Consent Decree Projects;
5. That the Guam Legislature, in P.L. 30-1 now requires that GEDA issue a single or multiple Request for Proposal(s) within thirty (30) days of enactment of this Act which would identify any viable alternative means of financing a remedy of the violation of the Clean Water Act at Lonfit River which led to the Consent Decree or any current violation of that Act at that location;
6. That an emergency procurement is requested to meet the legislative mandates of P.L. 30-1 for professional technical services to prepare the technical specifications for a bid invitation for a Finance, Build, Operate, and Lease Back (FBOL) to meet the requirements for USEPA compliant municipal solid waste services on Guam;
7. That the emergency procurement for professional technical services is not being used for the purpose of avoiding the provisions of the Guam Procurement Act which requires solicitation of competitive proposals after public announcement whenever public funds are used to acquire services;
8. I am authorized to make this declaration under GEDA's statute which includes providing assistance to the Government of Guam, its agencies and instrumentalities in obtaining of funds through bonds or other obligations.
