| <p>The Guam Ancestral Lands Commission (GALC) and the Guam Economic Development Authority (GEDA) are issuing a Request for Proposals (RFP-10-007) for the lease and development of six acres of Land Bank Trust property or portions thereof at Polaris Point in order to generate revenues for the GALC (Public Law 25-45). Privately-owned or claimed properties in the area are excluded from this RFP. This parcel is located along Polaris Point Road in Piti, near the entrance to the Naval Submarine Base.
