In accordance with Title 5 Guam Code Annotated (G.C.A.), §10107, the Guam Economic Development Authority (GEDA) hereby responds as follows:

# 5 GCA §10107. Annual Report

- (a) On or before February 1 of each year, each agency shall submit to the Attorney General of Guam a report which shall cover the preceding fiscal year and which shall include:
  - (1) The number of determinations made by the agency not to comply with requests for records made to such agency under §10108 of this Chapter and the reasons for each such determination;

## **GEDA's Response: 0**

(2) The number of requests for records pending before the agency as of September 30 of the preceding year, and the median of days that such requests had been pending before the agency of that date;

(3) The number of requests for record received by the agency and the number of requests, which the agency processed;

The Attorney General shall notify the Legislative Secretary of *I Liheslaturan Guåhan*, no later than April 1 of the year in which each such report is issued, that such reports are available by electronic means.
